The following resolutions are made in the deliberations:

1. Mr. R. Baskar has officially taken charges as the member of the Executive Council of BHUTA.
2. To thank the VC committee for considering and initiating actions to fulfill the requests put forth with them by BHUTA.
3. To request the University Authorities to release the arrears for the faculty members who were given pay fixation orders.

9. To request the University Authorities to consider merger of non-compound increments with Basic Pay and to sanction 3% of increment with effect from 1.9.2008.

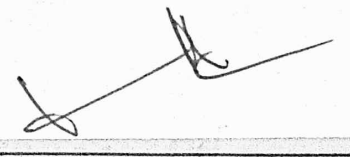
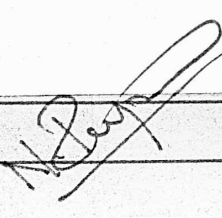
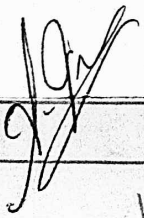
    


10. To request the University Authorities to direct the Heads of Departments to circulate the circulars without delay among all staff members of the Departments.

13. To request the University Authorities to direct the Heads of Departments to consider and respond to 'On Duty (OD)' letters submitted by the concerned faculty members well in time.
14. To request the University Authorities to provide fully furnished individual faculty rooms to all the members of faculty in our University.
15. To request the University Authorities to create a separate head of account named 'Publication Grant' in the Department Annual Financial Budget considering the number of faculty members and the subject specialization so as to encourage quality publications.
16. To request the University Authorities to upload the CAS application form in a downloadable (preferably in MSWord) format.
17. To request the University Authorities to appoint Coordinators to conduct the University Examinations at the Department on a rotational basis as this criterion would accrue Weightage in CAS promotions of members of faculty.
18. To request the University Authorities to consider the Seniority while allotting the Staff Quarters.
19. To invite VC-Committee members, Registrar, Office Bearers of non-teaching association of our University and AUT, TNGCTA, ACTA in the forthcoming General body meeting as a matter of expressing solidarity.

The meeting of the Executive Committee was held on 24.02.2016 to discuss various issues concerning the University and members of BHUTA. The minutes of the meeting given under are submitted for your reference:

1. It is learnt that the a huge fund amounting to Crores of Rupees had been deposited/transferred to Tamil Nadu Power Finance & Infrastructure Development Corporation Limited from the General Fund Account in the past. It is also learnt that, presently, the steps have been initiated to deposit/transfer the funds to the same Corporation from our University. When various issues of the staff at the University in terms of pension, salary, infrastructure, block grant, etc., are at stake, the process of transferring funds to a sick unit of the Government of Tamil Nadu is totally unwarranted. The executive committee expresses its displeasure and dismay over such actions of the University Administration. Hence, it is resolved to

- request the University Administration to bring out a white paper on (i) the financial position of the University, (ii) the funds which had been transferred in the past, (iii) the interest accrued and released by the Government to the University for the funds transferred/deposited and (iv) the funds which are being transferred/deposited
- request the University Administration not to proceed further on depositing/transferring funds from the University to Tamil Nadu Power Finance & Infrastructure Development Corporation Limited Corporation

- request the University Administration to initiate steps to get back the transferred/deposited funds from the Tamil Nadu Power Finance & Infrastructure Development Corporation Limited Corporation.

2. It is resolved to request the University Administration to initiate necessary steps to appoint Syndicate Members against the existing vacancies under the category of Professors at the earliest as per University Act and Statute.

3. It is resolved to request the University Administration to strengthen the existing departments with adequate faculty and infrastructure facilities rather than establishing new departments in the present situation.

4. It is resolved to request the University Administration to include the members of University faculty in the inspection commissions. It is further resolved that the University Administration may consider the suggestion that inclusion of Syndicate Members in the inspection commissions be avoided.

5. It is resolved to request the University Administration to review the appointments of Principals made at the Constituent Colleges of the University. As several members of faculty in the University are fully qualified to become Principals of such colleges, such appointments may be made with such members on tenure/deputation basis.

6. It is resolved to request the University Administration to adopt One Man – One Post policy, and accordingly not to appoint Head of One Department as to hold Head of any other Department.

7. It is resolved to request the University Administration to enhance the honorarium for the observers, research supervisors (internal examiner) and the external examiners of Ph.D. Viva-voce Examinations.

8. It is resolved to send the letter to the Controller of Examinations to initiate steps to provide remuneration to the invigilators during the University Semester Examinations held at the Departments.

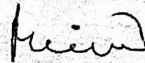

The meeting of the Executive Committee was held on 01.04.2016 to discuss various issues concerning the University and members of BHUTA. The minutes of the meeting given under are submitted for your reference:

- It is learnt that the a huge fund amounting to Crores of Rupees had been deposited/transferred to Tamil Nadu Power Finance & Infrastructure Development Corporation Limited from the General Fund Account in the past. It is also learnt that, presently steps have been initiated to deposit/transfer the funds to the same Corporation from our University. It is observed that the Tamil Nadu Power Finance & Infrastructure Development Corporation Limited is a non-banking institution and a sick unit of the Government of Tamil Nadu. When various issues of the staff at the University in terms of pension, salary, infrastructure, block grant, etc., are at stake, the process of transferring funds to such a non-financial institution is totally unwarranted. The executive committee expresses its displeasure and dismay over the decision of the University Administration.
- It is resolved to request the University Administration,
  - (a) to refrain from the decision of depositing/transferring funds from the University to Tamil Nadu Power Finance & Infrastructure Development Corporation Limited;
  - (b) to initiate steps to get back the transferred/deposited funds from the Tamil Nadu Power Finance & Infrastructure Development Corporation Limited;
  - (c) to avoid violation of the prevalent model code of conduct, it is requested to decide against favouring any move to deposit a fund with the Tamil Nadu Power Finance & Infrastructure Development Corporation Limited; and,
  - (d) to bring out a white paper on (i) the financial position of the University, (ii) the funds which had been transferred in the past, (iii) the interest accrued and released by the Government to the University for the funds transferred/deposited and (iv) the funds which are being transferred/deposited.

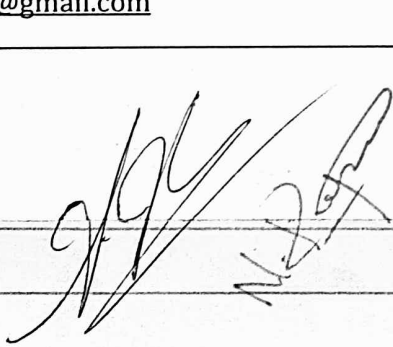
