- (c) to consider establishment of crèche for the children of the university employees;
- (d) to release the honorarium of Rs. 180/- per session for attending examination invigilation duty;
- (e) to consider and sanction uniform TA & DA for inspection committee members on par with syndicate members;
- (f) to ensure that syndicate members are not part of the inspection committee as they occupy statutory post;
- (g) to consider university teachers for the posts of Principals in the constituent colleges by receiving consent from them;
- (h) to consider the release of 25% of the overhead charges to the principal investigators;
- (i) to send a circular to the Staff to abstain from sending anonymous letters;






1. During the meeting, at the first instance, individual opinion on headship rotation expressed by the members of faculty in the prescribed format was enumerated and was observed that 71 members are in favor of headship rotation and 7 members are against it. In this regard, it is resolved to convey this to the University Administration for consideration.
2. It is resolved to place the following agenda for discussion in the ensuing general body meeting which is (tentatively) scheduled to be held on 06.10.2016 at 3:00 PM subject to the grant of permission by the University Administration:
 - Group insurance scheme
 - Annual subscription fee through Bank of India ECS
 - Corpus fund
 - Any other matter.
3. It is resolved to request the University Administration
 - (a) to prepare and submit the data in the prescribed format required by the UGC 7th Pay Review Committee within the stipulated date and to consult BHUTA while preparing the necessary data;
 - (b) to provide early solution to audit objections in the pay fixation in respect of few members of faculty during the past and present period by convening Joint Sitting of Finance and Local Fund Audit Sections;
 - (c) to prescribe fee towards extension for submission of Ph.D., and M. Phil., dissertation/thesis as equal and a maximum of Rs. 500/-;
 - (d) to ignore and nullify the contents of any anonymous / pseudonymous letters sent by the miscreants against the faculty members and officials in the University as per Central Vigilance Commission's circular dated 25.11.2014 and to place the same to the University Syndicate for closing all such files; and
 - (e) to consider Senior Professorship in the AGP of Rs. 12000/- for the eligible Professors as per UGC Regulations 2010.


