1. It is learnt that the government has sent a letter on temporarily transferring faculty members from Annamalai University. In this connection BHUTA expresses its reservations considering the following issues.

(i) There is no provision in the statutes of the University to transfer faculty from other Universities.

(ii) The redeployment may affect the reservation system followed in the University.

(iii) The redeployment may potentially affect the seniority of the existing faculty members of Bharathiar University.

Hence BHUTA requests the authorities not to move forward with the matter of redeployment of faculty from Annamalai University.

2. BHUTA requests the authorities to take necessary steps to sort out the problems faced by the faculty, students and scholars of the Department of Chemistry.
