After elaborate discussions it is resolved unanimously by the members to represent the following issues to the authorities for seeking earliest resolution. BHUTA submits the following representations based on the resolutions passed in the General Body meeting

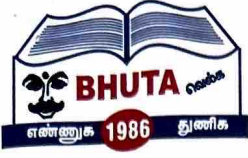
1. BHUTA considers that the audit objections related to non completion of Orientation and Refresher courses arbitrary, factually wrong, unsustainable and illogical. This issue has been brought to the knowledge of the authorities so many times but it is agonizing to see that the authorities turn a blind eye towards this unacceptable blunder committed by few people with motives beyond human comprehension.

BHUTA brings to the knowledge of the authorities, classic example of negligence and irresponsible behavior on the part of the auditors pertaining to objections raised against Dr.Narayanamoorthy, Assistant Professor, Department of Mathematics. He has completed the refresher courses within the stipulated period but while verifying the auditors have made a blunder and raised an objection. When the professor offered the explanation he was denounced mercilessly.

BHUTA requests the authorities to resolve the issue with immediate effect following the UGC and Government of TamilNadu guidelines and to order an enquiry against those people who misinterpret the UGC and Government of TamilNadu norms.

BHUTA unanimously requests that Mr.Selvaraj, the Assiatant Registrar of the E section is not performing his duties without bias and prejudice and hence he may be replaced by some other person to infuse professionalism.

2. BHUTA requests the authorities to expedite the process of CAS promotions. There is an undue delay in the process which directly affects the academic performance of the teachers. In the process of CAS no unnecessary conditions be laid down as they are totally contradictory to Government and UGC norms.
3. BHUTA requests that additional charges be given according to seniority of the teachers and on a rotation basis.
4. Seniority list of the teachers may be prepared at the earliest.
5. Syndicate members from the cadres of Assistant professor and Associate Professor may be made at the earliest because there was no representation for the past two years.
6. BHUTA requests that uniformity may be followed in the rotation of Headship.
7. BHUTA requests that Government of TamilNadu norms / UGC norms be followed in letter and spirit related to the allotment of duties to the teachers deputed from Annamalai University and teachers appointed under FRP scheme of UGC.

BHUTA requests the authorities that serious concern may be shown towards addressing the long pending grievances of the Teachers of the university so as to establish a positive academic ambience in the campus.
