The General Body meeting of BHUTA was held on 18.02.2019 at 03.30 P.M. in Dr. Usha Kirtilal Mehta Convention Center to discuss various issues concerning the University and members of BHUTA. The minutes of the meeting given under are submitted for your reference.

It has been decided to:

1. Maintain the annual membership fee for BHUTA at **Rs. 600/-**.
2. Request the authorities to **maintain the seniority while assigning additional charges** to the faculty members.
3. Request the authorities to adopt **Headship Rotation**.
4. Circulate all BHUTA communications **through the e-mails**.
5. Submit a memorandum to the Hon. Chancellor to **speed up the process of Vice-Chancellor appointment** to the University.
6. Request the authorities to see that any additional charge is not being held **for more than Three years by a faculty-in-charge member**.
7. Request the authorities to post the minutes of the **HOD's meeting in the intranet**.
8. Conduct **CAS every six months periodically** as per UGC regulations.
9. Initiate steps to renew the registration of the BHUTA association. The BHUTA office bearer Dr.S.Sundarabalu, Treasurer, along with Dr. R. Baskar, Department of Social Work was entrusted to look into the **renewal of the BHUTA association and necessary amendments to the association by-laws**.
